PRESIDENT - J. Wixson Smith

I've spent a lot of time this year communicating with many people at RIT on behalf of the club. One item which worked much better this year was our ice time calendar. With only a couple of minor glitches, we were able to inform our members of all of the major ice cancellations for the entire year at the beginning of our fall season. We plan to follow this model again for the coming year.

Our fall/winter session at Polisseni finished within budget. Our spring session at Ritter is looking good so far. Last summer at Ritter was not financially successful. We've taken some steps to correct that for this summer.

We eliminated our interim session between fall/winter and spring. There was no down time between those two sessions this year. We are planning an interim session between summer and fall. More about that as the time draws closer.

As a USFS National Official and a member of the software testing team for our scoring system, I've been very busy with USFS business this year.

Many thanks to the GFSC Officers, Board members, and Committee Chairs for their outstanding work which is outlined in the reports that follow. The staffs of the Ritter and Polisseni rinks continue to be easy to work with and are always appreciative of GFSC as a valued tenant of their facilities.

FIRST VICE PRESIDENT / RULES & ICE / SANCTIONS / SAFESPORT - Lynn Hayes

RULES & ICE - A reminder has been sent to all members regarding the number of junior skaters allowed in the music booth at any one time. One adult may also be in the booth.

Policy for the playing of programs has been created and published.

Clarification for make-up sessions was approved by the Board of Governors and sent to everyone on 22 February 2018.

Several reminders regarding right of way and related issues were sent during the course of the season.

Remember, GFSC rules apply to every member, parent and coach all year long. They also apply to all visitors on GFSC ice.

SANCTIONS - During the 2017 – 2018 GFSC season sanctions were granted for the December 2017 Holiday Show and the Spring Exhibition of 2018.

SAFESPORT - Since the Genesee Figure Skating Club was formed in 1954, it has adhered to the concepts of fair play, sportsmanship, a high standard of ethics, and respect for others, their feelings and their rights as members.

In 2014, sixty years later, the National Governing Bodies of organized sports developed a body of work known as SafeSport. It was adopted by the Governing Council of the United States Figure Skating Association in that same year. It was adopted by the Genesee FSC that same year and has appeared on our Membership Application ever since.

The GFSC has always striven to provide an environment for its members free of misconduct and harassment. This policy, now reflected in SafeSport, applies to members, officials, their families, guests, volunteers and coaches.

By following the Rules of our club and treating others as we wish to be treated, the Genesee Figure Skating Club and its members will always be in good standing on the SafeSport stage.

A team was formed and the show Committee selected coaches after a review process to choreographed a Theme Event "The Power of a Dream". This team of 8 skaters performed at two events on the RIT Campus Arenas. Their first event was hosted by the Rochester Global Connections in February and the second on February 23rd during the half time at a RIT Hockey Game. Both events were a success as it accomplished the goal of show casing our skaters and helping to promote our club. JUNIOR ACTIVITIES - Dolores Pasto-Ziobro

TESTS - Stephanie Dillingham

Testing had a good year. We held 5 test sessions and with each session I am finding the need to buy more ice to make room for more testers. It is with a friendly and cooperative attitude that the GFSC test sessions will continue to grow. GFSC saw 2 of it's own skaters pass their senior moves in the field, 3 skaters pass their gold dance tests and 1 skater pass their senior solo free dance test. Looking forward to the coming year I hope to expand the sessions further by bringing in a variety of judges and working with area coaches to help with their testing needs.
